

**THE CORPORATION OF THE COUNTY OF PRINCE EDWARD**

**BY-LAW NO. 1978 -2007**

---

**BEING A BY-LAW TO AMEND BY-LAW NO. 1122-2003, BEING A BY-LAW TO REGULATE SIGNS AND OTHER ADVERTISING DEVICES IN THE CORPORATION OF THE COUNTY OF PRINCE EDWARD.**

---

**WHEREAS** Section 10(2) of the Municipal Act, 2001, S.O. 2001, c.25, as amended, a provides that Councils of municipalities may pass by-laws respecting structures including fences and signs;

**AND WHEREAS** the Council of the Corporation of the County of Prince Edward adopted By-law 1122-2003 being a by-law to regulate signs and other advertising devices in the Corporation of the County of Prince Edward;

**AND WHEREAS** the Council of the Corporation of the County of Prince Edward deems it necessary to amend By-law 1122-2003 to include a clause that requires all drive through, take out restaurants and chip truck type vehicles to display a No Littering Sign.

**NOW THEREFORE** the Council of the Corporation of the County of Prince Edward enacts as follows;

1. **THAT PART 1 DEFINITIONS**, No. 3, to By-law 1122-2003 be amended to include the following new definition:

“SIGN, NO LITTERING – shall mean a sign pursuant to the Littering By-law No. 643-2001 as amended.”

2. **THAT PART 1 PERMIT EXEMPTION**, No. 5, to By-law 1122-2003 be amended to include the following new clause:

“1) No Littering Signs are required to be posted at all drive though, take out restaurants and chip truck type vehicles that indicates that the maximum fine for littering is \$3,000.00.”

3. **THAT PART II - REGULATIONS**, No. 7 SIGN LOCATION to By-law 1122-2003 be amended to include the following new clause:

“c) No Littering Signs shall be clearly visable from vehicles going through the drive through restaurant and at the point of purchase, or inside the restaurant and clearly visible to the purchaser.”

4. **THAT PART II - REGULATIONS** to By-law 1122-2003 be amended to include a the flowing new clause:


“18. NO LITTERING SIGNS – DRIVE THROUGH, TAKE OUT RESTAURANTS AND CHIP TRUCK TYPE VEHICLES

- a) A drive through, take out restaurant and chips trucks shall display a No Littering Sign that indicates that the maximum fine for littering is \$3,000.00.
- b) The sign is to be a minimum size of 2 square feet/0.6 square metres at the point of purchase, or inside the restaurant and clearly visable to the purchaser.

c) The minimum wording requirement, colour and size of the No Littering signs are to be determined by the County Planning Department and By-law Officers.”

5. **THAT** the provisions of this by-law shall come into force and effect upon the date of final passage thereof.

Read a first, second and third time and finally passed this 25th day of June, 2007.
